In closing, I want to recognize the career of one of SEPTLA's longest current standing members. David McClain, Head Librarian of Murphy Memorial Library at Baptist Bible College, is responsible for BBC&S' entry into SEPTLA, and has hosted and supported SEPTLA's mission for over 30 years. He officially retires as BBC&S' Head Librarian this June.

In 1962 David graduated from Baptist Bible Seminary and became pastor of a Baptist church [in Ohio.] In 1968, he returned to BBC&S as an employee in the library. By the early 70's he earned his MS in Library Science from Drexel University and eventually became the Head Librarian, the second one in BBC&S' history. Under David's leadership, Murphy Memorial Library tripled its collection from 33,500 volumes to over 100,000 volumes and he has pioneered the transition of the library into the digital age. During his career, he also has created or edited every MARC record in the Murphy Memorial Library OPAC to date. Upon retiring, David will continue his devotion to cataloging in the library. We'll miss you David, and may the Lord bless you throughout your retirement years!

SEPTLA Executive Committee Meeting Minutes

Biblical Theological Seminary

March 30, 2007

Attending: Dan LaValla, Cait Kokolus, Jeff Brodrick, Jerry Lincoln, Sandy Finlayson, Marsha Blake, Todd Wilmot, Debbie Stern

I. Reports

Secretary: Sandy has the minutes from the last meeting ready to submit to Stephanie for Teamwork. He will send email to the membership once more to solicit institutional news.

Treasurer: Debbie reported the following balances:

Checking account: \$1,926.00

Savings account: \$7,561.00

- Historical Society of PA has been paid \$1375.00 –1/2 of what's due for the reception including the wine and beer. Another check in the same amount will be given them on the night of the reception.
- Dan has two checks from donors to be deposited
- Storage Concepts has pledged \$1500.00 toward the tote bags, which will more than cover the cost. Any amount left over will be used for general Conference expenses.
- Dan and Debbie will transfer money from Savings to Checking to cover expenses related to the Conference.
- Jeff will create SEPTLA letterhead using the logo so that Dan can write official thank you notes to the sponsors.

Continuing Education: Todd reported that the committee would be meeting in April at Westminster Theological Seminary. The committee is working on arranging programs on the management and implementation of digitization projects. There has been some discussion with Darren Poley, from Villanova, in regard to their program. The group also suggested contacting Princeton to see about meeting there in the fall and asking someone from their staff to present a program on their digitization projects. Another possibility is contacting someone from UPenn involved in the same work.

Dan was in contact with a representative from PALINET who is interested in these projects in a consortial arrangement, in order to organize several projects into a database. It was noted that Dennis Norlin from ATLA is a newly appointed PALINET Board member.

We considered offering two separate programs in Fall '07 and Winter '08 centered on digitization. The Education committee will work on making this happen.

The full-day meeting in Spring 2008 will cover copyright issues, and consider the possibility of establishing a template for copyright.

Internet Technology: Jeff will present his own website that he developed as part of his library degree requirement. Part of the session will be devoted to a demonstration of establishing remote access to the library's database, using the experiences of Chris Beldan and Dan LaValla as examples.

Reference: Jerry's focus will be pre- and post- testing of students to assess Information Literacy as required by many accrediting agencies. He is aware of a pre-packaged test package available from the Educational Testing Service (ETS) at a cost of approximately \$100 per student, but will check on an open-source version that may be available at no cost.

II. New Business

- ATLA Conference

Barbara Kemmis notified Dan that we are on pace for 300 attendees with over 90 so far. She gave numbers of respondents for each offered excursion, some of which are full already.

ATLA will provide a sign for SEPTLA to welcome attendees at the hotel and also at the reception. The committee corrected errors and omissions in the list of host schools.

- SEPTLA bookmark: needs to be updated before May when we will need them to put into conference tote bags. Cait will contact Melody about this.
- Opening Reception:

Dan and Marsha met the caterer at the Historical Society of PA. A layout of tables and seating and setup of buffet and bar tables was reviewed by the committee. A revised bill was submitted by Casual Catering to include linens and small floral arrangements for each table. The additional elements added \$250.00 to the original estimate, for a total of \$4,467.50.

A HOST needs to be stationed at the door of the building to indicate the handicapped entrance to the building (around the corner) and to offer any other assistance needed.

A 'welcome' of some kind will be necessary from the Local Host group. Cait and Marsha will decide on an appropriate (short) welcome.

- Closing Banquet:

Cait reported that everything has been arranged at St. Charles. She will look into setting aside a secure space where people can leave their luggage if they are going directly to the airport from St. Charles. An additional bus has been arranged by ATLA to leave at 1 PM on Saturday to the airport, as well as the one back to the hotel at 4 PM that afternoon.

- Tote Bags:

The corrected version of the logo will be sent to ATLA. Dan and Todd will transport the 'stuffed' bags from Biblical to the Doubletree on Tuesday, June 12.

- Local Host Table:

Marsha reported that the table needs to be staffed from Wednesday – Friday at the Doubletree from noon – 7 PM each day. A signup sheet will be circulated at the May meeting for volunteers for each of those time slots. We will have a limited number of R1 and R5 train schedules available for the HOSTS to help people figure out times and trains. Since these schedules are readily available at either Market East or Suburban station, anyone needing a personal copy can pick one up there.

Karl Krueger has arranged to have pin badges printed up with LOCAL HOST on a red background as our identifier. Each attendee will have an ATLA badge as well with their name printed on it.

Stephanie Kaceli has compiled a list of restaurants noting proximity to the hotel, with directions, price range, website, and other helpful information. She is working on a list of houses of worship, taxis, etc.

- Saturday events:

The circulation desk staff at the Ryan Library at St. Charles can function as hosts while we're at the seminary. They might appreciate a list of taxis and fares from there to the airport for those not taking the buses provided by ATLA.

Marsha will send email to the SEPTLA listserv reminding people of the signups for the Host Table. We will also need restaurant hosts for those who will not be going on other excursions.

- Membership Updates:

Dan will be in touch with Dick Berg in order to send a donation in memory of Dawn Proctor.

The committee voted that Jeff Brodrick would be named the new SEPTLA Webmaster. We very much appreciate Chris Belden's willingness to step into the position temporarily after Dawn's death. Jeff will coordinate updating the website with Chris in time for the June conference.

Dan was approached by an historical society based in PA and its associated university from Virginia about potential membership in SEPTLA. We decided not to offer membership, since neither of these institutions meets the qualifications. The executive committee will review SEPTLA membership criteria at the August meeting.

The group discussed the changes described in the above articles, questioning the motivating factors driving the changes, whether the changes were necessary, and whether they were good or bad. Further discussion focused on how the changes affect online catalogs; user needs and behaviors; and relationships between managers and technical services librarians (which appear to be adversarial); and the future of the MARC format in light of the several non-MARC schemes now available. It was noted that bridges need to be built between managers and technical services librarians, and between traditional and emerging cataloging methods. It was recommended that the group continue discussions on the future of our field by reading other available documents, such as the Calhoun report.

Institutional News

Baptist Bible College & Seminary:

Welcomed our new Academic Dean, Dr. Jim Lytle on January 1.

We received approval by the state to offer a Master's in Biblical Ministries Degree. This on-line program is being offered through our Baptist Bible Graduate School.

The library added another database to its collection. The Thesaurus Linguae Graecae (TLG®) is a research center at the University of California, Irvine. Their database is a searchable digitized collection of most literary texts written in Greek from Homer to the fall of Byzantium in AD 1453. Ultimately, their goal is to create a comprehensive digital library of Greek literature from antiquity to the present era. The web version currently provides access to 3,700 authors and 12,000 works, approximately 95 million words.

David McClain is going to tour Israel in March. This is his second visit.

Lancaster Bible College:

Margaret Shickley, Head of Technical Services, will be retiring on June 30, 2007.

Remodeling has begun on an older dorm that will house offices while the Library is expanded

Lancaster Theological Seminary:

We have been saddened by the illness and death of our co-worker and friend Dawn Proctor. Since then we have missed both her and all she accomplished as part of our full-time staff of three. At the point of reporting we are in the final stages of hiring someone new for the position and looking forward to being back to full staff complement.

On a happier note, a new mural has been hung in the library foyer, the work of our seminary community under the direction of Nicaraguan muralist José Ignacio Fletes Cruz.

Lutheran Theological Seminary at Gettysberg:

Has a new director, Dr. Briant Bohleke.

Lutheran Theological Seminary at Philadelphia:

Are rearranging the collection and making use of compact storage.

Moravian Theological Seminary:

2007 marks the bicentennial year of Moravian Theological Seminary. Celebration events are posted on the MTS web site (www.moravianseminary.edu).

President Christopher Thomforde will be inaugurated on Saturday, April 21st.

Rita Berk, Reeves Library Director, has announced her retirement in June, 2008. The professional staff (including Rita) has spent the last six months doing a self-study in preparation for meeting with a team of three consultants who will help us determine what we will look for in a new director. The search for the director will begin in fall, 2007.

New Brunswick Theological Seminary:

Sage Library is pleased to welcome Ms Tolonda Henderson to the staff. Tolonda assumed the position of Librarian for Reference and Access Services on September 6, 2006. Tolonda comes to us with an M.L.S. from the School of Library and Information Studies at Dominican University and an M.A. degree from Chicago Theological Seminary. She previously worked at CTS as well.

In late April, NBTS will undergo its decennial ATS Accreditation Visitation. The Visitation Team will be on campus April 22-25. As that is the same week as the Spring meeting of our Board of Trustees, the Team will have the opportunity to meet with Board members as part of the visit. It will be a busy and exciting week!

Conversations continue with interested parties regarding the construction of new student housing at NBTS. If the conversations come to a successful conclusion later this spring, around June the current family residence (Scudder Hall) will be demolished, along with two older buildings (Kooy House and the unnamed One Seminary Place). In their place will be constructed a new building of about 145 apartments (with a variety of 1, 2 and 3 bedroom residences). Some will be used for seminary housing, the rest leased at market rates to citizens of the city of New Brunswick. The community is excited about this project, as it allows us to expand and upgrade our housing, while generating some additional income for the seminary.

Philadelphia Biblical University:

-Completed the first phase of the redesign of the rare books and archives area with the installation of compact shelving by Storage Concepts, Inc.

- Interviewing for a Readers' Services Librarian; a position left vacant with the retirement of Dorothy Black in October 2006.

- Continue to reclassify our collection from DDC to LCC

-The University will be instituting a new curriculum (changes in classes offered and credits needed) in Fall 2007.

Westminster Theological Seminary:

WTS has purchased Innovative Interfaces Millennium integrated library system which, it is hoped, will go live at the end of July, 2007.
