President's Message

SEPTLA member institutions differ from each other in a number of ways. Some of us cater only to graduate students, while others serve undergraduates as well. Some mainly see students of college age and slightly older, while others may also see those who return in mid-life to change careers or for enrichment. Some of the schools to which we are attached offer degrees in various academic disciplines, while others focus on formation for ministry through a limited number of programs. We also differ in the size of our collections, in special concentrations within our collections, and in the degree to which technological advancements have reconfigured the nature of our buildings and the services we provide.

Collectively, we differ from other libraries in the region because of our religion-specific identities. While libraries are, theoretically, ideologically neutral places, each SEPTLA member institution is distinguished by its association with a denomination or religious organization, and its attempt to tailor its services to that particular community. This does not mean, however, that we are under no obligation to be cognizant of, to be sensitive to, the various manifestations of spiritual awareness around us. If we are to live up to our names as theological librarians, we must keep our minds open to the diversity of viewpoints that, together, contribute so much to the continued religious vitality of our country.

The title of the main presentation at our upcoming Fall meeting, "Theological Librarianship in an Age of Religious Pluralism," got me thinking along these lines. Rabbi Nancy Fuchs-Kreimer, of Reconstructionist Rabbinical College, has graciously agreed to speak to us on this important and timely topic. I hope many of you will make the trip to Philadelphia Biblical University on October 17th to listen to her. In addition, our Reference/IT interest group will feature a presentation on certain facets of the e-book revolution. I also would like to note the efforts of our continuing education committee, who continue to do great work in supplying us with interesting guests and lecture topics.

Lancaster Bible College

Lutheran Theological Seminary at Gettysburg (LTSG)

The A. R. Wentz Library of the Lutheran Theological Seminary at Gettysburg (LTSG) announces the hiring of Mr. Harold Robinson as its newest staff member. After initial training, Harold has assumed his duties to cover Monday and Wednesday evenings and alternate Saturdays. He is a retired Air Force non-commissioned officer who also has worked at Gettysburg College.

New Brunswick Theological Seminary

The library sustained some basement water damage from the sump pump's inability to keep up with the rain fall during Hurricane Irene; however no books were damaged. With suitable restoration assistance, the library basement is now back open for business.

Professor Hak Joon Lee left the Seminary on August 31, 2011 to assume the position of Professor of Theology and Ethics at Fuller Theological Seminary in California. A search is underway for his replacement.

Academic Dean Renee House announced her resignation as Dean effective as of the end of the 2012 academic year. The Faculty will discuss how the search for her successor will take place.

Philadelphia Biblical University

Through the month of September 2011, the Center for University Studies was host to an exhibit in the Masland Library of ten prints from *The Saint John's Bible*, a modern, handwritten, illuminated text. The contemporary Bible was created by a group of scribes and artists in Wales, and this exhibit is currently on a tour around the country.

Reconstructionist Rabbinical College

Plans are being implemented to join the College with the congregational organization of the Reconstructionist movement, the Jewish Reconstructionist Federation. This should result in savings on administration and better position the restructured movement to train clergy and serve its congregations.
