### **Continuing Education Agenda**

"Librarian as Gatekeeper and Detective"

The presenter on October 16<sup>th</sup> is Karl Krueger. He earned his Ph.D. at the University of Michigan and his M.L.S. from Drexel University. In addition to course work in Rare Book Cataloging and Special Collections he has attended seminars at the Rare Book School at the University of Virginia. He has also developed *Book of Faith: Print, Politics, Public Event,* a fourteen week course for seminarians in their senior year that examines the history of the various editions of the Bible from the inception of movable type to the 19<sup>th</sup> century. In the afternoon session on October 16<sup>th</sup>, the rich holdings of the seminary's rare book collection will be utilized during the presentation.

- a. Palmer Theological Seminary
  - Palmer will be moving in December to ABC where the collection will be split into two
    collections.
- b. Biblical Theological Seminary
  - The seminary has an extension campus in Philly and it has been accredited. More library services have been needed for students at this site, and the usage has been monitored. Print usage will be hard, and Biblical has had to switch proxies student users due to costs.

### **Baptist Bible College & Seminary**

BBC&S recently received permission to offer a wider range of degrees. This year we will begin granting Bachelor of Arts and Bachelor of Science degrees in addition to Bachelor of Science in Bible degrees.

### **Cairn University**

Philadelphia Biblical University changed its name to Cairn University in July 2012 and the Library has been officially renamed Masland Library (previously Masland Learning Resource Center). BA degrees in English, History, Liberal Studies, and Music now offered.

The Library's recently renovated Exhibit Room has Grace Livingston Hill: Mother, Writer, Woman of God on display through May 2013 (<a href="http://cairn.edu/events/news/120917-Grace-Livingston-Hill-Gallery.cfm">http://cairn.edu/events/news/120917-Grace-Livingston-Hill-Gallery.cfm</a>).

Masland Library has moved from EbscoHost Integrated Search to Encore Synergy for its discovery platform and has signed on to migrate to Innovative's Sierra Services Platform in Spring 2013.

### **Eastern University**

This summer we moved the Austen K. deBlois Seminary Library from the City Line campus to the American Baptist Convention headquarters in Valley Forge. In preparation for that move we had the task of shrinking the collection from 111,000 to 80,000 volumes—no easy task.

The goal was to do as little damage to the Seminary collection as possible, even as we changed its shape and structure. To shrink the collection we had to work on both the Seminary and University library collections. We ran circulation reports and withdrew some books that had never circulated in either the Seminary or University libraries. We re-moved print copies of online periodicals

We moved a number of collections to St. Davids. Warner Library now houses the *J. Pius Barbour Black Studies Collection*. The *MacBride Collection* of classic humanities and social science texts resides in the Baird Library in Walton Hall. Portions of the *Santiago Soto-Fontanez Hispanic Collection* are now housed in three locations: Palmer Library, Warner Library, and Esperanza Library. A reference library of 2,500 books will be established at the Seminary by the end of September. Though unavailable for browsing, all the remaining books will be accessed by our staff on request. Increasingly, our collections will become interconnected re-sources for all Eastern communities.

### **Moravian College**

The Moravian College Joint Board of Trustees has launched a search for Moravian's 16th president, to succeed Dr. Christopher M. Thomforde when he retires in July, 2013. A presidential search committee has been appointed, chaired by David Bennett, vice chair of the Joint Board (of the College and Seminary). Reverend Bennett also serves as the President – Eastern District, Northern Province, of the Moravian Church.

### **New Brunswick Theological Seminary**

Fall 2012 has seen the arrival of four new faculty and a new Dean of the Seminary.

Willard Ashley has been appointed Acting Dean of the Seminary. He replaces Dr. Renee House, who retired June 30, 2012. Previous to his appointment he was Director of Field Education, and Associate Professor of Practical Theology at New Brunswick Theological Seminary, and Pastor of Abundant Joy Community Church (Newark, New Jersey). He has a M.Div. degree and a D.Min. degree, both from Andover Newton Theological Seminary.

Jaeseung Cha has been appointed Associate Professor of Foundational and Constructive Theology. Dr. Cha has M.Div. and Th.M. degrees from Western Theological Seminary (Holland, Michigan) and a Ph.D. in Systematic Theology from the Free University (Amsterdam, the Netherlands). Prior to his appointment he taught at the Presbyterian Seminary in the Philippines.

Dr. Bernadette Glover has been appointed Associate Professor of Preaching and Worship, after many years serving as a member of our adjunct faculty. She has a M.A. degree in Theological Studies from Eastern Baptist Theological Seminary (now Palmer), and a Doctor of Ministry degree from United Theological Seminary (Dayton, Ohio). She also served for many years as Executive Pastor of Cathedral International, a large Baptist congregation in Perth Amboy, New Jersey.

Matilde Moros has been named Acting Director of Field Education and Assistant Dean of Special Programs and Initiatives. She is possessed of a Master of Theological Studies degree from Harvard Divinity School, a Master of Divinity degree from Princeton Theological Seminary, and is currently a Ph.D. Candidate (ABD) at Drew University, Madison, New Jersey. Her specialty is Christian Social Ethics.

Neal D. Presa has joined the Seminary as Assistant Professor of Preaching and Worship (Affiliate). He comes to us with a M.Div. degree from San Francisco Theological Seminary, a Th.M from Princeton Theological Seminary, and M.Phil. and Ph.D. degrees from Drew University (Madison, New Jersey). An ordained Presbyterian, Dr. Presa also serves as Moderator of the Presbyterian Church (USA).
